NOTICE OF RACE

ORGANISING AUTHORITY

The Organising Authority shall be Mooloolaba Yacht Club Ltd. (MYC) located on the First Floor at The Wharf Mooloolaba, 123 Parkyn Parade, Mooloolaba QLD 4557

1. INVITATION

Mooloolaba Yacht Club Ltd, as the organising authority, invites owners, skippers and crew of eligible racing and cruising yachts to enter the 2019 Easter Shield to be held in Moreton Bay and the coastal waters off the Sunshine Coast on the 4th and 5th May 2019.

2. RULES

The race will be governed by:

- (a) The rules, as defined in the Australian Sailing (AS) Racing Rules of Sailing ("RRS") 2017 2020 of the World Sailing (WS)
- (b) Prescriptions and Special Regulations (SR) of Australia Sailing except for any which are modified by this Notice of Race or the Sailing Instructions.
- (c) The Sailing Instructions for this regatta.



3. ELIGIBILITY

- 3.1 Yachts shall be thoroughly seaworthy and meet the safety categories as specified in 5.1 of this Notice of Race.
- 3.2 Attention is especially drawn to Fundamental Rule 4, Decision To Race,
- 3.3 It is the responsibility of each yacht to ensure that every member of the crew satisfies the requirements of RRS 46

4. ENTRIES

- 4.1 Completed entry forms for the Easter Shield, accompanied by the entry fee of \$20 shall be lodged with the Club Administrator at MYC by 1800 on Friday 26th April 2019
- 4.2 The total entry fee for the MYC 2019 Easter Shield, including the Hart Cup, is \$50. \$30 to be paid directly to WMSC following registration as indicated in 4.3 below.
- 4.3 Register for the Hart Cup online through the WMSC website and complete payment by EFT as instructed or by contacting WMSC (Jenny or Karen) on (07) 3393 5708.
- 4.4 Berthing at the WMYC Marina for Friday 3rd May should be organised through the WMYC Marina Office (Sonya or Karen) on (07) 3396 4639.
- 4.5 Berthing for entrants visiting Mooloolaba should be arranged for The Wharf Marina at the Wharf Marina Office (phone (07) 5353 6045 or Mooloolaba Marina Office (07) 5444 5652. Berths are limited and should be booked early.

5. SAFETY

5.1 The AS Safety Category for the Easter Shield series is designated as Safety Category 4: for Divisions 1, 2 and 3 for Race 1 (Manly-Mooloolaba Race and Jim Craddock Memorial Race) and for Race 2 (Brian and Trent Anstee Memorial Race).

6. RACING DIVISIONS

Racing will be conducted in the following divisions:

Division 1 Performance – spinnaker Division 2 Cruising non-spinnaker

Division 3 Multihull

Provided that -

- (a) 5 entries are received to form a division
- (b) Divisions may be formed by combining entries (where there are less than 5) or subdivided (where there are significantly differing speed potentials) at the discretion of the Race Committee depending upon entries.

7. CERTIFICATION, INSPECTION

Owners (or owners' agents) of yachts shall submit to the Mooloolaba Yacht Club, no later than 1800 on Friday 26th April 2019 the following documents:

- (a) Current Safety Compliance Certificate,
- (b) Insurance Currency Certificate
- (b) Completed entry form and
- (c) Completed crew form.

8. RACING AREA

Race 1 (Hart Cup) will be conducted in the waters from a start position in the vicinity of Lockyer Light in Moreton Bay to nearby to the Mooloolah River entrance at Mooloolaba, a distance of approximately 52Nm.

Race 2 will be conducted in coastal waters off the Sunshine Coast between Morton Bay and Coolum. The course to be notified on the day of the race.

9. BRIEFING

Compulsory briefings will be conducted for skippers at 1830 hrs on Friday 3rd May 2019 at Wynnum Manly Yacht Club at the Clubhouse for the Hart Cup (Manly to Mooloolaba Yacht Race) and 0900 hrs on Sunday 5th May 2019 at the MYC Clubroom, First Floor at The Wharf Mooloolaba for the Brian and Trent Anstee Memorial Race.

12. HANDICAPS

- 12.1 Apart from measurement division, handicaps shall be allocated according to the speed potential of the individual yachts. TCFs shall be allocated at the sole discretion of the Race Committee or its nominee. The handicaps allotted to a yacht shall not be grounds for protest.
- 12.2 A boat shall not be allocated a handicap for the event unless a valid certificate is produced.

13. SCORING SYSTEM.

- 13.1 The Low Point Scoring System (A4.1) of the RRS Appendix A will apply.
- 13.2 In the Performance Spinnaker, Cruising Non-spinnaker and Multihull divisions two races are scheduled. Two races count, no drops.
- 13.3 Two races are required to be eligible for the Easter Shield.

14. PRIZES

- 14.1 Prizes will be awarded for 1st in each Division for each race subject to race entries. These will be presented at 1700hrs on Sunday 1st May 2019.
- 14.2 Additional Prizes may be awarded at the discretion of the Sailing Committee.
- 14.3 Perpetual Trophies for The Jim Craddock Memorial Race, Brian and Trent Anstee Memorial Race and The Easter Shield will be awarded a the MYC Annual Prize Giving 2019.
- 14.4 Prizes for the Hart Cup will be awarded in accordance with the Hart Cup Sailing Instructions.

15. INSURANCE & LIABILITY

- 15.1 All persons taking part in these races do so entirely at their own risk and responsibility. The Organising Authority, the sponsors, their servants and volunteers will not accept any liability for damage or personal injury or death sustained in conjunction with, prior to, during, or after the race. The Race Committee reserves the right to refuse any entry.
- 15.2 It is required that all boats competing in this regatta hold current Third Party Property Liability of at minimum of \$10,000,000 per event.
