# NOTICE OF RACE - 26 SOUTH FLEET for SAILING SEASON 2020/2021

## For Mooloolaba Yacht Club and Sunshine Coast Yacht Club

Races Covered by this Notice of Race will be those races designated as club events in the MYC / SCYC Sailing Calendar 2020/2021.

## 1. ORGANISING AUTHORITY

The Organising Authority for all events will be the Mooloolaba Yacht Club Ltd (MYC) and the Sunshine Coast Yacht Club Inc (SCYC).

Sailing documents will be published on each club's website:

- SCYC: <u>www.scyc.net.au</u>.

#### 2. RULES

- 2.1 All races will be governed by the rules as defined in Australian Sailing (AS), The Racing Rules of Sailing (RRS) 2017-2020.
- 2.2 The rules and regulations of the respective Class Associations.
- 2.3 The AS-Special-Regulations-Part-1-Keelboats, 2017-2020 except where modified by these Sailing Instructions.
- 2.4 Skippers and Owners are reminded of Special Regulations Part 1, Rule 1.01.2 indicating the Special Regulations are supplementary to requirements of governmental authority, the Rules of Racing, and the rules of class associations and rating systems.
- 2.5 Between the hours of sunset and sunrise, the International Regulations for Preventing Collisions at Sea (IRPCS) shall replace the rules of Part 2 When Boats Meet.
- 2.6 The Australia Sailing (AS) 2017-2020 Special Regulations Part 1, Sections 1-8, shall apply.
- 2.7 The Safety Category for each race will be designated in the Sailing Instructions.
- 2.8 Throughout the 2020/2021 sailing season all boats competing in 26 South Fleet events must continue to comply with the (Open Water) Covid-19 Safe Plan of their respective club. Further, prior to competing in any event, the skipper of each boat must have signed their club's Covid-19 Safe Plan Compliance and returned it to their club. The Plan and Compliance agreement are available from the member's club.
- 2.9 All participants must conduct themselves in a respectful manner and must show courtesy, consideration and respect to all others

#### 3. ADVERTISING

Events shall be classified as Category C in accordance with World Sailing Regulation 20, Advertising Code and the prescriptions of the AS. Boats may be required to display advertising chosen and supplied by the Organising Authority.

## 4. ELIGIBILITY AND ENTRY

- 4.1 Events are open to all boats on the MYC and the SCYC Boat Registers and boats on the register of clubs or other organisations affiliated with Australia Sailing (AS). All boats not on the MYC or the SCYC Boat Registers will provide in writing to the OOD at least 1 hour before the first Start the skipper's name, boat name and type and sail number.
- 4.2 All skippers and crew shall be members of SCYC or MYC or bona fide visitors. See RRS 46. Visitors who are not already a member of a AS affiliated club may purchase a SailPass according to the Club's policy. It shall be the responsibility of the person in charge of a boat to ensure that for each race all crew or visitors on board comply with these rules.
- 4.3 Eligible boats may be entered for Wednesday Afternoon Members' Sail (WAMS), Sunday Afternoon Members' Sail (SAMS), Wednesday Afternoon Members' Sail Non-pointscore (WAMS-NPS) and Sunday Afternoon Members' Sail Non-pointscore (SAMS-NPS) races by signing-on with the Officer of the Day (OOD) on the day of the race.

- 4.4 For all series or other events, eligible boats may enter by forwarding the required documentation from the following list to MYC / SCYC or by lodging it with the OOD on the day of the race -.
  - (a) Completed entry form including proof of membership of an AS affiliated club:
  - (b) Entry fee.
  - (c) Safety compliance form (available from MYC / SCYC website).
  - (d) Fully completed crew list on the form provided (if required).
  - (e) Completed COVID-19 Compliance Form.
  - (e) Copy of boat insurance (Certificate of Currency).
- 4.5 For the Lady Helm Races, boats wishing to be included in the results for this series shall have a female helm throughout the designated race. Other boats not qualifying for Lady Helm may be entered into the SAMS-NPS series where indicated in the Sailing Instructions (SIs).

#### 5. FEES

Club members may enter an individual race by paying the published entry fee.

#### 6. SCHEDULE

The schedule of races will be as per the 26 South Fleet Sailing Calendar 2020/2021 available on each club's website:

Amendments to the Sailing Calendar will be updated to the websites as necessary.

#### 7. SAILING INSTRUCTIONS

Sailing Instructions (SIs) for club events in the 26 South Fleet Sailing will be published on each club's website.

#### 8. COURSES

The Courses will be as defined in the Sailing Instructions.

#### 9. PENALTY SYSTEM

The penalty for breaking a rule of Part 2 shall be a One Turn Penalty (one tack and one gybe in the same direction). This changes RRS 44.1 and 44.2.

#### 10. HANDICAPPING

- 10.1 The official Performance Handicap list will be issued by the Organising Authority. The Organising Authority at its absolute discretion, reserves the right to alter or adjust any performance handicap prior to the scheduled starting time of the race concerned.
- 10.2 The Organising Authority reserves the right to alter or adjust, at any time, any handicap found to be incorrectly published in Supplementary Sailing Instructions or incorrectly calculated.
- 10.3 The Combined Sailing Committee (CSC) or its nominee may at its absolute discretion review any boat's handicap where it's of the opinion that due to anomaly, error or change of racing trim or equipment, the handicap is considered unfair or unreasonable.
- 10.4 Allocated handicaps will not be the subject of protest or dispute. Requests for review of a handicap must be in writing to the CSC, stating specific reason(s) for the request. Any changes will not be retrospective.
- 10.5 WAMS and WAMS-NPS will be conducted under the Pursuit Race handicapping system. Handicaps will be adjusted using TopYacht software. The Start Time for first boat will be not before 1145. For boats that have started, but Did Not Finish, or boats that did not race on the day, handicaps will not change.
- 10.6 All club races will be conducted under a Performance Handicap System (PHS) based on Corrected Elapsed Time handicapping using TopYacht software. Three (3) or more boats must be entered to constitute a race and for handicaps to be adjusted. Before a boat has completed its third race handicaps for club races will be provisional and subject to change by the CSC or its nominee. Handicaps for club races will be allocated after a boat has completed its third race.
- 10.7 Additional divisions may be declared if there are sufficient entries for IRC, OMR and/or SMS.

- 10.8 Any substantial modification to the boat, increase in sail area, change of skipper or even change of on-board skill which is likely to change performance must be declared to the CSC
- 10.9 Skippers are obliged to declare any change in or addition to the sail wardrobe including new and replacement sails.

## 11. SCORING

- 11.1 The Low Point System, RRS Appendix A will apply except that the number of discards allowed will be as amended in 11.2.
- 11.2 The number of discards for scored races will be as follows:

- 11.3 Competitors who join a Series after one or more races have been run will be awarded a DNC for each earlier race.
- 11.4 Race scores will be as per RRS A9 except as follows. For boats that have come to the Starting Area but Did Not Start (DNS), started but Did Not Finish (DNF) or Retired (RET) will be scored points for the finishing place one more than the number of boats that came to the starting area. Boats that Did Not Come to the Start Area (DNC) will be scored points for the finishing place two more than the number of boats that came to the starting area. This changes RRS A9.
- 11.5 For average points to be applied a boat representing the MYC or the SCYC in an away race or being unable to sail due to volunteering commitments, the boat owner must apply in writing to the Duty Club prior to the race. Where granted, average points will be applied using the TopYacht software. This changes RRS A4.
- 11.6 To be eligible for series points each boat shall sign off confirming their Finish Time by either:
  - by radioing in their Finish Time on VHF Channel 69 to Race Control, or
  - by sending a Text Message (SMS) to the OOD mobile as advised at sign on,
  - within 45 minutes of their Finish Time and no later than 15 minutes after the last boat finishes.

## 12. RADIO COMMUNICATIONS

- 12.1 All boats shall carry a marine band VHF transceiver capable of receiving and transmitting on Australian marine channels. Boats shall use the radio to sign on, report retirement from racing and may use the radio to report finish time or to request assistance in an emergency. No other transmissions are permitted by competing boats during the racing day from the first warning signal until the end of the last race of the day. The Race Committee may use the radio to advise competitors of race information. This restriction applies to mobile telephones.
- 12.2 Mooloolaba Coast Guard may monitor Channels 16 and 73 during races.
- 12.3 All radio transmissions relating to racing will be on VHF 69.
- 12.4 All skippers are encouraged to install a cockpit speaker for VHF radio or carry a waterproof handheld VHF in the cockpit or as required by AS Special Regulations Part 1 For Racing Boats in accordance with the race category,

## 13. 26 South Fleet ANNUAL PRIZES

- The Long Bay Series
- Hawkwind Cup
- Lady Helm Series

Prizes for races may be awarded for each race and series.

## 14. DISCLAIMER OF LIABILITY

Competitors participate in 26 South Fleet races entirely at their own risk See RRS 4, Decision to Race. Neither the MYC nor the SCYC will accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after a race. All those taking part in these races are reminded of their obligations as set out in AS Special Regulations Clause 1.02 "Owner's Responsibility". Attention is drawn to RRS 3, (Acceptance of the Rules) and RRS 4, (Decision to Race).

#### 15. INSURANCE

All boats shall carry third party insurance of not less than AUD\$10 Million.

## **16. SPECIAL CONDITIONS**

- 16.1 While racing in any 26 South Fleet racing events no anchors shall be carried on deck forward of the stem or with any part protruding outboard. Boats found to do so shall be scored as DNS. The primary anchor shall be carried assembled and attached to the ground tackle.
- 16.2 Use of autopilot is permitted. This changes RRS 52.
- 16.3 Minimum crew in any boat shall be two persons.
- 16.4 A boat may use prohibited propulsion after the Preparatory Signal to arrive at the start line provided it carries out a 360 degree turn, keeping clear of all other boats, after ceasing to use such propulsion and before starting (Changes RRS 42.1).
- 16.5 Skippers and Owners are reminded of Special Regulations Part 1, RRS 1.02, Owners Responsibility, outlining their responsibilities for ensuring that their boat is adequate and safe. Skippers are responsible for ensuring that their boat complies with equipment requirements as specified by the race Safety Category. Equipment audits may be made available throughout the sailing season for boats requesting a review of their compliance. Any boat failing to comply with equipment requirements may be subject to protest by the Race Committee.
- 16.6 Skippers should be mindful that until all boats have completed a race each boat in that race is required to act as a safety vessel for all other boats in that race if they require assistance.
- 16.7 A decision to race on any given day does not relieve any competitor of his/her obligation under RRS Fundamental RRS 4, Decision to Race.
- 16.8 Members are requested to fly their club pennant on their vessel when competing in 26 South Fleet events

## 17. AQUATIC EVENT AUTHORITY

It is a boat owner's responsibility to remain informed about and comply with the conditions of and any changes to their club's Aquatic Event Authority.

# SAILING INSTRUCTIONS - 26 SOUTH FLEET for SAILING SEASON 2020/2021

## For Mooloolaba Yacht Club (MYC) and Sunshine Coast Yacht Club (SCYC)

#### 1. RULES

- 1.1 All races will be governed by the rules as defined in Australian Sailing (AS), The Racing Rules of Sailing (RRS) 2017-2020.
- 1.2 The rules and regulations of the respective Class Associations.
- 1.3 The AS-Special-Regulations-Part-1-Keelboats, 2017-2020 except where modified by these Sailing Instructions.
- 1.4 Skippers and Owners are reminded of Special Regulations Part 1, Rule 1.01.2 indicating the Special Regulations are supplementary to requirements of governmental authority, the Rules of Racing, and the rules of class associations and rating systems.
- 1.5 Between the hours of sunset and sunrise, the International Regulations for Preventing Collisions at Sea (IRPCS) shall replace the rules of Part 2, When Boats Meet.
- 1.6 The Australia Sailing (AS) 2017-2020 Special Regulations Part 1, Sections 1-8, shall apply.
- 1.7 The Safety Category for each race will be designated in the Sailing Instructions.
- 1.8 Throughout the 2020/2021 sailing season all boats competing in 26 South Fleet events must continue to comply with the (Open Water) Covid-19 Safe Plan of their respective club. Further, prior to competing in any event, the skipper of each boat must have signed their club's Covid-19 Safe Plan Compliance and returned it to their club. The Plan and Compliance agreement are available from the member's club.
- 1.9 All participants must conduct themselves in a respectful manner and must show courtesy, consideration and respect to all others

## 2. NOTICE TO COMPETITORS

Notices will be posted on each club's website (see NOR clause 1) and/or notice board when available.

## 3. CHANGES TO THE SAILING INSTRUCTIONS

- 3.1 For all 26 South Fleet races, any change to these Sailing Instructions will be posted no later than one (1) hour before it will take effect, except that any change to the schedule of races will be posted by 2000 on the day before it will take effect.
- 3.2 All changes to sailing instructions will be posted on each club's website and/or notice board when available.

## 4. SCHEDULE OF RACES

4.1 These Sailing Instructions apply to races designated Wednesday Afternoon Members' Sail (WAMS), Wednesday Afternoon Members' Sail - Non-pointscore (WAMS-NPS), Sunday Afternoon Members' Sail (SAMS), Lady Helm Series (LHS) and Sunday Afternoon Members' Sail - Non-pointscore (SAMS-NPS) events in the current 26 South Fleet Sailing Calendar 2020/2021.

SAMS and WAMS are pointscore series, SAMS-NPS and WAMS-NPS are non-pointscore events.

4.2 The scheduled Warning Signal time will be in the 26 South Fleet Sailing Calendar 2020/2021 or in the Supplementary Sailing Instructions (SSIs).

## 5. CLASS FLAGS

## 6. RACE CANCELLATION

- 6.1 Races will only be cancelled after careful consideration of current and predicted weather, sea and bar conditions and their likely impact on the course area.
- 6.2 Racing will not occur if there is a Gale Wind Warning (34 47 knots) current.
- 6.3 The Race Committee / OOD shall monitor the current weather conditions, wind speed and forecasts prior to and throughout the race. The Race Committee/OOD shall postpone or abandon racing if before or during a race a review of well-respected weather forecasting sources indicates a significant risk of severe storms or sustained wind speeds of 26 knots or more within the race area during the racing period. During the race the OOD may shorten or abandon a race if changing forecasts, weather conditions or sea state indicate potentially dangerous conditions.
- 6.4 The decision to race, postpone or abandon will not be made before Sign-On on the day of the race unless circumstances indicate that an earlier decision would be appropriate. This decision is not subject to protest.

## 7. THE COURSES

Courses will be designated in Attachment E of the Supplementary Sailing Instructions (SSIs).

#### 8. MARKS

#### 26 South Fleet LAID MARKS

Mark A	Laid approximately upwind of the start line at a distance and bearing that may be displayed by the start boat Mark A will only be laid if a red/green rounding direction flag is displayed.
Mark N	Laid at least 0.45 Nm from the Port Beacon (Beacon no 2) on the transit of the outer Port and Starboard Marks on the retaining walls of the Mooloolah River at approximately <b>26° 40.293S   153° 08.084E</b> .
Mark D	Laid approximately 150m inside Mark N on the transit of the outer Port and Starboard Marks on the retaining walls of the Mooloolah River at approximately <b>26° 40.372S   153° 08.062E</b>
Noosa	Laguna Bay at approximately 26° 22.200S   153° 05.550E

**Mark Rounding Time:** The OOD may require each boat to record its Mark Rounding Time. The Mark Rounding Time should be taken when the boat completes the rounding as the stern of the boat passes the rounding mark.

#### 9. RACES DESIGNATED NON-EXTRAS

For WAMS and WAMS-NPS races, boats may normally only carry normal working sails tacked in the normal position for working to windward. Boats shall not carry additional headsails, spinnakers or the like. Headsails may be poled out but must be tacked to the foot of the forestay and fully hanked or attached to the forestay by a luff groove device. If other furler only straight-luffed headsails not attached to the forestay, eg furling Code Zero, Screecher or Asymmetrical sails are carried then this must be declared to the CSC prior to the commencement of the series and a WAMS Handicap penalty of 4.5% will be applied.

#### 10. THE RACE START / FINISH

10.1 For WAMS and WAMS-NPS races, boats will be allocated Start Times. For SAMS, SAMS-NPS and LHS races, fleet start times will be as follows:

From 01 September 2020 – 31March 2021 a fleet start for all boats at 1230. Boats with a handicap <0.800 may join a fleet start at 1200. From 01 April 2021 – 31August 2021 a fleet start for all boats at 1200. Boats with a handicap <0.800 may join a fleet start at 1130.

- 10.2 Boats whose warning signal or handicap start time has not been made shall avoid the starting area during the starting sequence for other races.
- 10.3 The Start-Finish Line for SAMS, LHS, WAMS, and WAMS-NPS / SAMS-NPS races will be between the laid buoys on Mark N and Mark D. Otherwise, if Mark D is not laid, the Start-Finish Line will be between the laid buoy on Mark N and a virtual Mark D as designated by its GPS position as stated in clause 8 of these SIs. If both Mark N and Mark D are not laid the Start-Finish line will be between virtual Marks N and D. Please note that Marks N and D may or may not be precisely on the transit line of Beacons 1 and 2 this shall not be the subject of protest or dispute.

Boats will finish the race by crossing the Start / Finish line from the direction of the course defined in The Racing Rules of Sailing (RRS) 2017-2020.

Starting and Finishing directions in relation to Mark N will be determined by the designated course chosen by the OODs are as tabled below.

**Mark Rounding Time:** The OOD may require each boat to record its Mark Rounding Time. The Mark Rounding Time should be taken when the boat completes the rounding as the stern of the boat passes the rounding mark.

10.4 For other fleet start races, where a Committee Vessel is present, the following will apply:

a) All races will be started by using RRS 26, with the warning signal made five (5) minutes before the starting signal.

b) A boat that crosses the starting line more than 20 minutes after its starting signal will be scored DNS.

- c) The starting line will be between a staff displaying an orange flag or shape on the Race Committee Vessel at the starboard end and the start Mark at the port end.
- d) A starting limit mark may be laid near the starting line (though not necessarily on the line) or floated from the Race Committee vessel. This mark shall be left to starboard when starting and (for the purpose of the RRS) will be deemed to be a part of the vessel it protects.
- e) When Mark A has been laid, the Race Committee vessel will signal the side on which this mark is to be passed by the display of a red flag- port or a green flag starboard, at or prior to the warning signal.
- f) Divisions can be started separately or together.
- 10.5 The Race Committee vessel may hold position using engines. This shall not be grounds for redress and amends RRS 60, 61, 62, 63 & 64.

## 11. THE FINISH

- 11.1 When there is no Race Committee vessel on station competitors shall take their own finish time in the format of "Hour: Min: Sec" EST by GPS. Competitors shall Sign-Off:
  - by radioing in their Finish Time on VHF Channel 69 to Race Control or,

• by sending a Text Message (SMS) to the OOD mobile as advised at sign on within 45 minutes of their Finish Time and no later than 15 minutes after the last boat finishes.

11.2 Each boat in the race is required to act as a safety vessel for all other boats in that race if they require assistance. The second to last boat to finish shall wait for the last boat in the fleet to finish and assist to pick up the Laid Marks from the finish line.

## 12. SHORTENED COURSE:

During a race the OOD may advise boats by radio on VHF 69 that the course is to be shortened. To assist with this decision the OOD may request position and sailing conditions from boats sailing the course. The OOD may advise to complete the course at the finish line as described or at any mark on the selected course. If a course is to be completed at a rounding mark each boat should record its Mark Rounding Time as described in Clause 10.3. The OOD may require each boat to record its Mark Rounding Time at a specified Mark and later declare that as the Finish of a shortened race. This changes the definition of Finish and RRS 32.

## 13. TIME LIMITS

The Time Limit for all races will be designated in the Attachments to the Sailing Instructions

## 14. PROTESTS AND REQUESTS FOR REDRESS

- 14.1 Protest forms are available from the Duty Club
- 14.2 The protest time limit is one (1) hour after the finish time of the last boat in the last race of the day.
- 14.3 Protests shall be delivered to the Duty Club or the OOD before the end of the protest time limit.
- 14.4 Protest notices will be posted online not more than 48 hours after the end of the protest time limit to inform competitors of the time and place of a hearing to which they are a party or named as a witness.
- 14.5 Protests will be heard as soon as practicable, and in the approximate order of receipt.
- 14.6 For the purpose of RRS 64.3(b) the authority responsible is the Duty Club. The Protest Committee will be appointed by the OOD of the Duty Club or the CSC.
- 14.7 When Division Boats are scheduled to finish away from Mooloolaba, a boat intending to protest shall notify the Race Committee Vessel as soon as practicable after finishing and comply with the requirements of RRS 61.1. The completed Protest form must then be lodged with the Duty Club.
- 14.8 Entrants are reminded of Fundamental RRS 3 acceptance of the rules. The Race Committee looks to the competitors to enter the event in the right spirit, be meticulous in observing the rules and participate in a sportsmanlike manner.

## 15. SCORING

- 15.1 The Low Point System, RRS Appendix A will apply.
- 15.2 Each boat's series score will be the total of her race scores excluding the specified number of worst scores.
- 15.3 The number of discards for scored races will be as follows:

- 15.4 Competitors who join a series after one (1) or more races have been run will be awarded a DNC for each earlier race.
- 15.5 Race scores for series longer than a regatta will be as per RRS A9 with the last paragraph changed as follows. For boats that have come to the Starting Area but Did Not Start (DNS), started but Did Not Finish (DNF) or Retired (RET) will be scored points for the finishing place one more than the number of boats that came to the starting area. Boats that Did Not Come to the Start Area (DNC) will be scored points for the finishing place two more than the number of boats that came to the starting area. This changes RRS A9.
- 15.6 Race scores for a regatta will be as per RRS A4.
- 15.7 For average points to be applied a boat representing their club in an away race or being unable to sail due to a Start Boat commitment, the boat owner must apply in writing to the Duty Club prior to the race. Where granted average points will be applied using the TopYacht software. This changes RRS A4.
- 15.8 To be eligible for series points each boat shall sign off confirming their Finish Time as detailed in 11.1.

## **16. SAFETY REGULATIONS**

16.1 From 01 February 2021 PFDs standard AS1512 will not be acceptable. The current standard for life jackets is Australian Standard 4758 (AS 4758.1) was introduced in 2008 and updated in August 2015. Any of the following standards are acceptable provided the lifejacket is in good condition and does not rely solely on oral inflation for buoyancy:

In accordance with AS 2017 – 2020 Special Regulations 3.12.1 Where lifelines are not fitted to a multihull or are not continuous, the crew shall wear safety harnesses which shall be attached at all times when the crew member is outside the cabin.

In accordance with AS 2017 – 2020 Special Regulations 5.01.1 j: On a boat without lifelines complying with 3.12, a lifejacket complying with 5.01.1(i), shall be worn by each member of the crew while on deck.

- 16.2 All boats shall lodge a completed Australia Sailing (AS) Special Regulations Equipment Audit Form covering the appropriate safety category prior to racing in any event. Boats failing to comply with this requirement will be scored DNS
- 16.3 A boat that retires from a race shall notify the OOD as soon as practicable.

## 17. SPECIAL CONDITIONS

- 17.1 While racing in any 26 South Fleet racing events no anchors shall be carried on deck forward of the stem or with any part protruding outboard. Boats found to do so shall be scored as DNS. The primary anchor shall be carried assembled and attached to the ground tackle.

- 17.2 Minimum crew in any boat shall be two persons.
- 17.3 A boat may use prohibited propulsion after the Preparatory Signal to arrive at the start line provided it carries out a 360 degree turn, keeping clear of all other boats, after ceasing to use such propulsion and before starting (Changes RRS 42.1).
- 17.4 Skippers and Owners are reminded of Special Regulations Part 1, Rule 1.02, Owners Responsibility, outlining their responsibilities for ensuring that their boat is adequate and safe. Skippers are responsible for ensuring that their boat complies with equipment requirements as specified by the race Safety Category. Equipment audits may be made available throughout the sailing season for boats requesting a review of their compliance. Any boat failing to comply with equipment requirements may be subject to protest by the Race Committee.
- 17.5 Skippers should be mindful that until all boats have completed a race each boat in that race is required to act as a safety vessel for all other boats in that race if they require assistance.
- 17.6 A decision to race on any given day does not relieve any competitor of his/her obligation under RRS Fundamental RRS 4, Decision to Race.
- 17.7 Members are requested to fly the club pennant on their vessel when competing in 26 South Fleet events.

#### **18. AQUATIC EVENT AUTHORITY**

It is a boat owner's responsibility to remain informed about the conditions of and changes to their Club's Aquatic Event Authority.

#### **19. RADIO TRANSMISSION**

- 19.1 All boats shall carry a marine band VHF transceiver capable of receiving and transmitting on Australian marine channels. Boats shall use the radio to sign on, report retirement from racing and may use the radio to report finish time or to request assistance in an emergency. No other transmissions are permitted by competing boats during the racing day from the first warning signal until the end of the last race of the day. The Race Committee may use the radio to advise competitors of race information. This restriction applies to mobile telephones.
- 19.2 It is recommended that all boats monitor and transmit on VHF Channel 16, 73 and 69. All radio traffic relating to 26 South Fleet racing will be on VHF 69.
- 19.3 The 26 South Fleet OOD call sign is "Race Control".
- 19.4 Start Boat call sign is "Start Boat".
- 19.5 MYC Base call sign is "MYC Base", SCYC Base call sign is SCYC Base".

#### 20. PRIZES

Prizes for races may be awarded for each race and series.

#### 21. DISCLAIMER OF LIABILITY

Competitors participate in 26 South Fleet races entirely at their own risk. Neither the MYC nor the SCYC will accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after a race. All those taking part in these races are reminded of their obligations as set out in AS Special Regulations Clause 1.02 "Owner's Responsibility". Attention is drawn to RRS 3, (Acceptance of the Rules) and RRS 4, (Decision to Race).

#### 22. INSURANCE

All entrants shall carry third party liability insurance of not less than AUD\$ \$10 million.


